The Tolkien Society keeps membership information on computer. We reserve the right to pass this information on to Tolkien Society Trading Ltd. (a company wholly owned by the Society whose profits are covenanted to the society). Information about Gift Aid payments will be passed to the Inland Revenue. (Registration Number D1125205.)

Your right to cancel

Unless you hand your form to us in person you have the right to cancel your membership within 7 working days of sending us your application, you must send your cancellation in writing to the address below or by email to membership@tolkiensociety.org, except in these circumstances we do not give refunds on membership payments. However this right to cancel ceases once we have started to provide the service. The service starts once we have passed your membership pack to a Universal Postal Service provider or given you a valid password to the members pages of our website whichever is sooner. The membership service will start within 60 days of receipt of valid payment (120 days for surface mail outside Europe) -- note: our aim is to be much quicker and these maximum times are to allow for postal and other delays outside our control. You may pay for membership for 12, 24, 36 or 48 months, your membership will automatically cease at the end of this period unless you pay for a further period.
